
1. The Institute/College shall submit an affidavit to the University positively by 31st July, 2009 on the non-judicial stamp paper duly attested by the First Class Magistrate to the effect that they shall appoint all the faculty on regular basis as per NCTE Norms through duly constituted Selection Committee as per Kurukshetra University rules and get the same approved from the University before the commencement of classes for the session 2009-10. In the event of non-submission of this affidavit by the stipulated date of 31st July, 2009, the Institute/College will be debarred from participating in the admission process and making admission to B.Ed. Course for the session 2009-10.
2. After having assessed your college on the 500-point scale proforma, duly approved by the Executive Council of this University, the Inspection Committee constituted by the Vice-Chancellor has reported some major deficiencies in respect of your Institute/College, which are being conveyed to the NCTE. The college shall, therefore, remove the deficiencies before the commencement of classes for the session 2009-10 under intimation to the University (copy of the Inspection Report enclosed).
